Announcing the Gaylord Atkinson Memorial Scholarship

Thanks to a generous donation from Jay Chatham, GHF will be granting scholarships for graduate level research in memory of Gaylord Atkinson, a former board member and Groundhog volunteer at the Prairie Center during the 90's. Gaylord was particularly active at GHF's former office prairie in Roeland Park, fighting Japanese honeysuckle, and hand building a boundary fence with

his grandfather's tools. After he moved to Texas, he continued to support GHF and he shared stories of his time with us. His good friend, Jay Chatham, is honoring Gaylord with this memorial.

Overland Park Embraces Native Plants in Ordinance Update

We work hard to protect and grow native plants, and challenges can get in the way, such as gaps in knowledge, availability of native plants and seeds, and incompatible landscape maintenance. One frustrating barrier to native plant proliferation is municipal ordinances that define some native plants as 'weeds,' or restrictions on plant height that thwart residents' hopes of exploring Kansas plants, supporting pollinators, and reducing fertilizer and irrigation needs. Cities are also interested in using deep-rooted native plants to control and absorb stormwater. In November 2023, the City of Overland Park, Kansas adopted an ordinance update that provides exemptions to height limitations for planned native and foodproducing gardens. It replaces a city-defined weed list with

the weed lists maintained by Johnson County and the Kansas Department of Agriculture, and it requires setbacks and clearly-defined boundaries for native and food gardens. Prior to this change, the Overland Park ordinance conflicted with a Johnson County program, Contain the Rain, that encourages native plantings with reimbursements for plant purchases. Seventeen cities in the Kansas City metro and unincorporated Johnson County are participating in Contain the Rain. In Lawrence, the city's Sustainability Advisory Board has been preparing recommendations for ordinance updates to clarify enforcement of noxious weeds, and to promote the use of native plants and sustainable landscaping, for City Commission review. Watch for more activity on this issue in 2024.

Good Work and Persistent Problems: A Prairie Park Update

In the September 2023 newsletter, we shared the awful news that herbicide had been sprayed on a native prairie in Lawrence's Prairie Park. Updates are limited at this time. The appearance of the site has indeed changed with the removal of a row of trees next to the nature center, from an area that was, historically, prairie. Watch for restored prairie and an outdoor classroom designed by a University of Kansas Design/Build class, funded by the Douglas County Community Foundation Elizabeth Schultz Environmental Fund and arranged by Native Lands Restoration Collaborative (NLRC).

Kansas Biological Survey (KBS) faculty have made monitoring visits to collect data on how plant diversity and distribution might have changed as a result of the herbicide spraying. Anecdotally, the prairie appears to be more grass-dominant in late 2023 than in previous years. If true, this is an unfortunate sign of loss of forbs on the prairie. A more informed assessment of the damage may be possible once KBS completes more data collection and analysis. The city has arranged for monitoring through summer of 2024. sumac and other woody plants from the native prairie, and GHF funded an additional work day. GHF submitted a list of suggested immediate, short-term, and long-term mitigation measures to protect the prairie, such as removal of the sericea lespedeza and honeysuckle that had been a problem on and around the prairie prior to the herbicide application. City Parks & Recreation staff say they have not made removal of honeysuckle and sericea lespedeza a higher priority at the native prairie over other land managed by the city. Parks & Recreation staff may need support and education over time to develop into professional native landscape managers.

City Parks & Recreation staff told GHF that the department is reassessing its Integrated Pest Management Plan, and that there may be a Prairie Park Plan in the future.

GHF will continue to coordinate with other prairie advocates and to promote prairie management and natural areas in the current Park Plan development for Lawrence Parks and Recreation. Also, look for opportunities to support the completion and adoption of the Douglas County Open Space Plan in early 2024.

The City sponsored workdays led by NLRC in 2023 to remove

Thanks to the many donations from our members, grants for special projects, and another year of successful plant sales, GHF was again able to achieve several of our project and financial goals. We completed a second year of work at the Kensington Road restoration site at Prairie Park in Lawrence utilizing a Natural & Cultural Heritage Grant from the Douglas County Heritage Conservation Council. The Prairie Park project will end next summer. GHF funded a workday at the Prairie Park native prairie, and we added a workday at Black Jack Battlefield and Nature Park near Baldwin in November to continue controlling woodies in the prairie restoration.

We continue to utilize the EQIP cost share funds at our Snyder Prairie north of Topeka. The work on this project will end next year. Also, GHF provided 3 \$1,000 scholarships in the spring to college students for prairie-related research. We received a generous donation in October to support these scholarships next year. We completed the first year of our Sustaining Prairie Fund, providing grants to organizations for maintenance and education work at existing prairie plantings. The Lordi-Marker Matching Fund will allow us to continue to help other groups next year with the funding to enhance and maintain their prairie plantings. Without your donations, GHF could not accomplish this important work.

Much of GHF's focus this year has been on the Prairie Park restoration project. GHF, Native Lands Restoration Collaborative (NLRC) and the KU Field Station held a seed cleaning event at the Field Station that brought over 60 people out to help clean seed that will be used for the restoration project.

Additional partners on the project include Haskell Indian Nations University, Kansas Association of Conservation and Environmental Education, and the City of Lawrence Parks and Recreation Department. We held four events in the spring and four events in the fall. We kicked off the Spring with an Earth Day event where attendees planted wildflowers and

learned about the use of native plants to dye fabric with local artisans. This event also celebrated the new non-profit status of NLRC! In total, about 150 volunteers gave almost 350 hours of time to this project. In 2023 alone, GHF and NLRC volunteers cleared over 3.5 acres of bush & Japanese honeysuckle, Callery pears, and other woody species, and planted over 500 native wildflowers, grasses and sedges. The City of Lawrence helped to increase awareness of our work through sharing our events and posting photos and videos online, and we had over 20 volunteers attend our final two fall workdays. We appreciate the time and energy of everyone who have helped us make this project a success!

We closed out the fall work season for Prairie Park with a seed collection event in partnership with the newly-formed Douglas County Seed Team: a partnership between NLRC, Bridging the Gap, and Kansas Land Trust. We enjoyed a spectacular autumn day collecting seed at Blazing Star Prairie, home of NLRC. An extra big 'thank you' to Courtney & Ryan of NLRC for hosting this event and sharing their land with all of us. The scaly blazing star (*Liatris squarrosa*) was in full seed & we can only imagine the glory of this patch when it is blooming!

After the unfortunate herbicide damage at the remnant prairie at the Prairie Park Nature Center, residents of Lawrence, botanists, GHF, and other organizations asked the City of Lawrence to mitigate the damage and better manage and protect prairie and other native landscapes. The GHF board voted to fund an additional workday at the remnant prairie on Oct. 11 to remove invasive smooth sumac and other woody plants. We will continue to monitor management of the prairie.

GHF has continued the restoration work at Black Jack Battlefield and Nature Park in partnership with NLRC. Although our

we have continued to maintain a relationship with the Black Jack Trust to support the project. Prairie restoration is a longterm commitment and requires diligent and intentional stewardship. In July, GHF hosted a Prairie Talk & Walk highlighting the research that KU Doctoral student & GHF Board Member, Reb Bryant, has been conducting at Black Jack. We learned about the role of arbuscular mycorrhizal fungi in assisting the successful establishment of many prairie wildflowers, such as purple prairie clover (*Dalea purpurea*). In early October, we hosted another workday to remove invasive black locusts from the restoration area. We were gifted with beautiful weather and attendees for both events!

GHF continued to support native plants in gardens and landscaping this year by hosting three plant fundraiser sales in 2023. Our first plant sale was at the Prophet Aquatic Research and Outreach Center at Emporia State University. Next, our largest sale of the year was our Annual Spring Plant Sale, held in Lawrence. We held one fall plant sale at our native plant demonstration garden, The Little Prairie at Little Prairie Community Garden. Umut Bayramoglu of the Common Ground community garden and urban agriculture program hosted us and gave garden tours. We sold over 4,700 plants in 2023, which is the second largest number yet!

At Little Prairie Community Garden, Board Member Roxie McGee continues to nurture and maintain GHF's native plant demonstration garden. We plan to continue native garden workshops there in 2024. We also continue to care for the native garden in historic Oak Hill cemetery in Lawrence. To get involved with either of these gardens, please email us at grasslandheritage@gmail.com.

grant-funded project was officially completed in June of 2022, stewardship and land protection. We will begin 2024 with a seed cleaning day in early January with NLRC and the Douglas County Seed Team, followed by seed spreading at the Prairie Park restoration site in Lawrence. We will continue our work at Prairie Park, with workdays in the Spring, closing out the grant with a Prairie Day celebration on National Prairie Day on June 1. We look forward to continuing conversations about how to protect, preserve, and steward prairies in eastern Kansas.

We continue to partner with our neighbors, Groundhogs volunteers and Custom Forestry Applications to ensure that necessary stewardship activities continue at Snyder Prairie. Custom Forestry Applications has helped spot spray sericea lespedeza (Lespedeza cuneata), large stands of rough leaved dogwood (Cornus drummondii), and other encroaching woody plants. Many thanks to Luke Terry and his crew at CFA for your hard work and helping GHF be good stewards of Snyder Prairie!

We will burn this winter as weather allows, to further diminish the vigor of undesirable species while increasing the vigor of native prairie species to better outcompete them. To participate, email us at grasslandheritage@gmail.com.

GHF will continue management activities related to our EQIP grant to increase the number and types of milkweed plants at Snyder Prairie to improve the habitat for monarch butterflies. This work includes seeding two additional fields this winter with a mix of five different milkweed species. We will also host monthly Groundhogs work days, on the 2nd Saturday of the month as weather allows. Email us at grasslandheritage@gmail.com to receive Groundhogs updates!
